

Les nationalismes québécois face à la diversité ethnoculturelle

La question nationale demeure non résolue au Québec, puisque l'option souverainiste semble incertaine dans l'immédiat bien qu'elle soit fortement revendiquée, et que l'option fédéraliste n'apporte pas de réponses atisfaisantes pour une large proportion de citoyens et de forces politiques. Or l'option nationaliste fait face à de nombreux défis, certains relevant de la conjoncture politique et économique internationale, et d'autres de la reconfiguration du paysage politique et démographique au Québec. Plusieurs de ces défis concernent la pensée nationaliste/indépendantiste face à la diversité ethnoculturelle. Entendons par là l'immigration et le fait minoritaire au Québec dont il faut rappeler l'hétérogénéité intra et intercommunautaire. En effet, si la diversité ethnoculturelle a toujours été constitutive de la société québécoise, l'immigration contemporaine suscite aujourd'hui de nouvelles interrogations concernant les modalités de son incorporation économique, politique et culturelle à la nation québécoise, ces enjeux concernant d'ailleurs l'ensemble du peuple québécois. Dans ce nouveau contexte et à l'instar de ce qui se passe dans plusieurs démocraties occidentales, le thème de l'identité nationale est redevenu un sujet délicat et un objet de controverse. Et c'est la façon même dont les nationalismes se pensent et définissent l'identité nationale ainsi que leurs frontières avec l'altérité qui est en pleine transformation.

Le présent colloque se veut un moment de réflexion sur les nationalismes québécois face à la diversité ethnoculturelle, par le biais de ce qui fait la spécificité de la Chaire : l'étude et la prise en compte de l'ethnicité et de la citoyenneté.

La diversité ethnoculturelle minoritaire sur le territoire du Québec suscite plusieurs questions. Quel statut a-t-elle dans la pensée des nationalismes? Comment ce statut s'inscrirait-t-il dans les projets de constitution, de république et de citoyenneté québécoises? Quelles orientations émanent des perspectives nationalistes sur l'aménagement de la diversité ethnoculturelle, la question des droits et la lutte contre les discriminations? Quelles positions originales émanent des minorités ethnoculturelles elles-mêmes au sein de la mouvance souverainiste en particulier?

Plusieurs thèmes qui interpellent les chercheurs universitaires émergent alors, dont, par exemple :

- Les figures et les transformations historiques du nationalisme québécois (ethnique et culturel ; civique et républicain) et la question de la citoyenneté
- Les perceptions (d'ailleurs diversifiées) des minorités ethnoculturelles face à la question nationale
- La résurgence du nationalisme conservateur et l'affirmation d'une droite nationaliste

Today, common sense and scientific analysis seem to converge claiming the increase of speed, multiplicity and simultaneity of time and temporalities. But what is the actual sense of temporal processes? What is really new in contemporary societies and their time schemes? How do institutions respond to temporal transformations? What does time and temporality have to offer to research in social sciences and humanities?

These are some of the issues that will be discussed during the seminar that brings together researchers interested in the debate about time, rhythm and social temporalities.

The political extremes: (dis)qualifications, (dis)positions, transfers.

3rd 4th October 2013

In the introduction of a collective book published in the direction under their direction in 2006 and from a roundtable of the French Political Association of Political Science in 2002, Annie Collovald and Brigitte Gaïti were noting: « "Fanatism", "clash of civilizations", "irresistible rise of racism" and of "working-class authoritarianism": so many alarmist reports in the face of what seems to threaten today the norms, the ideals, and the principles of every democraty. The use of physical violence (entry into the armed struggle, terrorism, hostage-taking) and more broadly the refusal of arrangements and compromises which supported the peaceful policy rules would directly test the democratic order established; these phenomena would find their political location in all forms of extremism (extrem right, extrem left, islamism, nationalism, separatism) and their social location in groups returned to the ages of the democratic world; immigrant youth from the suburbs or the Muslim Arab countries, the unemployed or undocumented today somehow replacing yesterday's workers or farmers. » (Collovald et Gaïti, 2006)

We could add, to complete these synthetic overview of habitual ways of thinking about phenomena known as « extremists », the wide diffusion among political commentators and beyond, of the hypothesis of a twinning betwin the extremes (particularly between groups classified as « extreme left » and those classified as « extreme right) that fall into the same fact « totalitarianism » (Christofferson, 2009). One can notice, six years after the publication of the book, the still widespread in the political and intellectual analysis merely explain « extremism » in general personality frustrated, authoritarian, violent, Manichean (Ory, 2012 : 11-14). The symposium « the extreme politics : (dis)qualifications, (dis)positions, transfers », open to recent research enrolled in different theorical traditions and in different disciplines (sociology, political science, social history, etc.) intends therefore to contribute, following the book edited by A. Collovald and B. Gaïti, renewal of political commitments understanding, discourse, practices, commonly classified in a form of « extremism ».

Going against essentialist and normative approaches which attribute the phenomena called "radicals" or "extremists" clean and distinctive features (a violent "nature" for example) at the same time suitable for certain groups of attitudes fundamentally undemocratic and authoritarian, Annie Collovald and Brigitte Gaïti proposed in their book research program inspired interactionist and constructivist endeavoring to identify the process (reversible) radicalization situations and rules, groups and men indexed tipping themselves on several types of temporality (temporality that transform ways of thinking and doing is not the same as the temporality that is change "frameworks of interpretation and meaning joined to practices or those representations"). Out of the theoretical tradition mobilized by them and derives a special interest in "the work of labeling and its effects to construct a reality that it intends qualify" (Collovald and Gaïti, 2006: 12). Politics - "activity that consists of doing things with words" (Cohen et al., 2009: 15) - is indeed crossing categories and representations (socially and historically situated) with a character "performative" in that they form the political reality. Also opens the conference the contributions focusing more specifically the mechanisms of production of "Other" violent, dangerous and threatening, as disqualification of political groups outside the peaceful democratic game, whether an "enemy within", and / or devices (or other) to curb these threats (Collovald, 2001; Rigouste, 2009; Biard et al., 2012). The constructivist approach is not without its limitations if it merely presupposes the effectiveness of stigma. The conference intends to ask about the social and historical conditions of a successful identity assignment. As far as this issue is concerned, contributions that take into account the resources and social trajectories of individuals or groups and undertake an analysis of the structure and dynamics of social spaces in which individuals or groups evolve, will be welcome (Kestel, 2012).
