#### **Trade Unions in the Democratic Process**

It will also consider the options available to trade unions in existing democracies to shape developments, particularly in light of the growing socio-economic problems and new challenges that they face in many of these democracies. The conference will focus on the initial situations, developments, processes and results of trade union influence in very different countries, regions and political frameworks. International comparisons and historical perspectives are also possible and desired. In particular, the conference will cover the following topics and issues: What functions do trade unions assume in democratisation and/or democracy stabilisation processes? In what way are trade unions political players in their operative frameworks and functions? How do they present themselves? What are the definitions and interpretations of democracy from a behaviour influencing perspective? How do the trade unions collaborate with their alliance partners in the democratic process? How do the trade unions' strategic concepts compare at an international level? What roles do trade unions play in repressive regimes? To what extent have trade unions adapted to changing work situations and demographic shifts (e.g. to the "internship generation" in industrial nations, migrants or the very young average age of many populations in the southern hemisphere)? What functions do trade unions assume in connection with the inclusion and integration of marginal set groups? What function do the ILO and other international trade union organisations assume in the above connection? What is the significance of transnational networks? What kind of a media presence do trade unions have in the democratic process?

#### 40th World Congress of the IIS: "After Western Hegemony: Social Science and its Publics"

**Topics:** The last decade of the 20th century and the first decade of the new century have witnessed world historical developments that point to the beginning of the end of what might be called the colonization of minds and cultures. Ideas and practices associated with the modern West have been critiqued for long, viewed with suspicion, and rejected, rightly or wrongly, in the past. But never before has the impact of this critique been profound enough to launch a transformation in the social and political imaginary of large numbers of people in the world. A new historical dynamics appears to have been set in motion and a space has emerged for new cultural and civilizational encounters. This may entail greatly increased potentials for equality between human beings in different regions of the world but perhaps also the emergence of new structures and spaces of hegemony. The beginning of the end of the hegemony of mainstream Western intellectual traditions may therefore be the right moment to reflect about the relationship of the social sciences to this transformation. How have the social sciences shown an awareness of adaptation to these world historical changes? Is social science still shot through with assumptions of Western modernities? To what extent, if any, may such assumptions still be justified and to what extent are they amenable to rethinking and rearticulation and to what extent will they have to be discarded?

## Declining Political Trust, Disenchantment with Politics, and Methods of Political Participation

**Date:** January 25-27, 2012 **Site:** Cologne, Germany

**Organiser:** GESIS Leibniz-Institute for the Social Sciences

Topics: Over the last two decades, disenchantment with politics has become more noticeable around the globe as people feel a growing distance between governments and governed. When asked, some voters state that politicians do not listen to what the people want, causing many to turn away from politics in frustration. Others voice their opinions in the streets, protesting against political decisions, thus demonstrating that they want to have their say in politics - not just on Election Day. At the same time, public opinion surveys suggest that political trust is declining meaning that people are less and less confident in their governments and other political institutions. Is there a connection between trust in and disenchantment with politics as the public debate often suggests? If so, what are the reasons behind this development? The literature offers a variety of economic, social, cultural and political explanations for declining levels of trust; similar factors are usually mentioned when disenchantment with politics is concerned. Can we identify major driving factors from this potpourri of potential explanations? Are the same mechanisms at work in all affected countries? And if so, under which conditions might citizens re-invest trust into the political system? Taking into account the theoretical and practical relevance of political trust for modern democracies and the open questions that still remain after about 50 years of research, further work on the topic seems in order. The organizer encourages contributions addressing the questions raised above, or the meaning and transformation of the concept in different time periods or countries, or new ways of measuring trust. In particular the organizer suggests using the existing comparative data bases (such as CSES, EVS, Eurobarometer, ESS, ISSP). Manuscripts should cover either one country for more than one period of time, or compare several countries, or both.

A special emphasis will be placed on integrating the insights of those focused on dynamics in the city and those addressing the broader phenomenon of nationalism, to enliven debates on space, identity, and politics and to illuminate important convergences and contradictions, conjunctures and disjunctures. ### Multi-level Governance and Partnership in EU Cohesion Policy

Date: November 29-30, 2011

Site: Vienna, Austria

Organiser: Institute for European Integration Research (EIF), Austrian Academy of Sciences

**Topics:** The first workshop organised as part of the Research Network will tackle the issues of multi-level governance and partnership in EU cohesion policy. The imposition of multi-level and horizontal cooperation in implementation of cohesion funding challenged the established patterns of interaction between the levels of government and the actors involved in regional policy delivery. The partnership principle has also been praised for its positive impact in terms of improvement of administrative capacity and favouring learning across organisational boundaries. In addition, effective multi-level governance mechanisms and horizontal partnership are also considered as crucial for purposeful and strategic use of the Structural Funds. Thus, EU cohesion policy is expected to become more results-oriented in 2014-2020 thanks to, among other measures, an emphasis on a place-based approach, a concept closely linked with multi-level governance and partnership. However, there are major barriers for the functioning of multi-level governance, such as reluctance of some national governments to allow the sub-

national actors to play a more important role; or lack of capacity at the regional level to actively take part in shaping and implementation of EU cohesion policy, particularly in countries with centralised and hierarchical administration systems. Likewise, as the ex-post evaluations of 2000-2006 period and the academic research to date suggest, the application of horizontal partnership varies considerably across the Member States and can remain superficial and 'formal.' Against this background the organizer proposes to address the following issues during the workshop: 1. Application of the multi-level governance and EU cohesion policy's partnership principle in the Member States; 2. Added value and spillover effects; 3. Enhancing multi-level governance and partnership.

### Challenging Identity Normativity: Affirmative Social Identities, Empowerment Policies and Social Cohesion

Topics: The focus of this call is to discuss those social identities which are devalued, ostracized and stigmatized and to look at the empowerment policies towards social cohesion, justice and inclusion. While identity politics has become an important topic in social sciences in so-called Western countries already in the late 1960ies, countries with state socialism, like former Yugoslavia, experienced a pre-defined normative identity formations and the invisibility of the identity politics from the perspective of the individual persons. During the collapse of state socialism, from the beginning of the ethnic conflicts and wars in former Yugoslavia, the issue of identity was primarily focused on the re/construction of the collective identity such as national identity, heroic identity, the mothers' of war veterans identity, the victim of war identity and similar. In the meantime, several others social identities became newly defined or visible for the first time (people with disabilities who demanded independent living; the "Erased" in Slovenia; people living in the same sex partnerships; parents who adopt children from other countries, women experiencing violence, working poor, unemployed workers from the mainstream society, migrant workers, illegal immigrants etc.). Many of above mentioned social identities have in the course of the transition from communism towards the neo-liberal global capitalism became viewed as the source of societal disintegration, pathologised and ostracized as the deviation from the normative identity of the collective identity of the national body and its parts. This construction of the internal »others« helped to construct seemingly ethnically, politically and socially homogeneous new states. Coming from that, the proposed (but not exclusive) topics of this call are: The particular contexts in which specific social identities become source of discrimination and conflicts; The manifestations of everyday hatred, including everyday racism; The common structure of social inequality, which is manifested in variety of ways: pathologisation, constructed invisibility, memory restrictions etc.; The everyday life experiences of people from their own perspective; The examples of the affirmative empowerment policies towards devalued and discriminated social identities; The involvement in policy work in order to change the oppressive environments. Proposed research questions include: What are some of the important new social identities and how are they defined in regard to the normative identity formations in the particular contexts? What are the normative forms of social exclusion and stigma related to particular social identities? What are the ways of developing the affirmative identities, what are the empowerment policies and inclusionary practices that are going to affect social cohesion?

What is expected here is not only copy editing (correcting spelling, grammar, word usage, etc.), but also and overall content assessment (Is there a clear statement of the research question? Is the research method or approach relevant? Was it properly executed? Are there mistakes, unclarities, lacks or problems? Are the results consistent with the research design? ...). The refereeing process will take place from 10 March to 20 May 2012. Meeting the deadlines is critical.

**Eligibility:** Sound experience as a researcher; Experience as a referee; Familiarity with most specialties in disciplinary area, or with various areas of Humanities and Social Sciences research; Native English speaker or Bilingual French-English; Good command in the use of Microsoft Excel and Word, especially the Track Changes mode and the Insert Comment function of Word; Availability to perform the reviews within the abovementioned periods of time; Demonstrated reliability in meeting deadlines; Willingness to adapt to- and comply with the evaluation procedure in use in the Academic Committee.
