## **Structures and Futures of Europe**

Date: May 20-21, 2011 Site: Budapest, Hungary

**Topics:** European political structures are facing new challenges. The Lisbon Treaty, after so many setbacks, has come into force in a period when the economic crisis has threatened the EU's most widely known project, the Eurozone. The effective coordination of national economic policies appears to be more necessary than ever, but it is unclear what new forms of cooperation will emerge among governments, community institutions and markets. Enlargement continues to pose a challenge, while the integration of the new members is, in many respects, still rather a hope than a reality. The EU provides economic and political stability in its close neighborhood, but failure to increase its competitiveness raises questions about its global relevance. The political and academic debates concerning the "democratic deficit" focus the attention on the issue of legitimacy in a multilevel political system, without, however, producing a coherent set of institutional reforms. Given this context, and given Hungary's EU presidency of the European Council in the first half of 2011, the Hungarian PSA's Annual Meeting this year focuses on European integration, broadly conceived. The panels will cluster into five sections: forms of governance, responses to crisis, political actors, Europe in the world and open section. The last section welcomes proposal from all areas of political science.

Duration: The position will start on the 1st May 2011 and run initially for three years, with the possibility of renewal for further two or four years, subject to mutual agreement between the editor and Publications Board. Topics: The ECPR is currently advertising for a new co-editor of the EJPR's Political Data Yearbook (PDY). Of the seven issues of the EJPR published each year, one is the double issue Political Data Yearbook (PDY), which reports data concerning cabinet composition and election and referendum results, and provides a narrative and interpretation of the principal political issues and events within each of the EU member states, Israel, Norway, Switzerland, the United States, Canada, Australia, New Zealand, and Japan. This list might also be extended to include Turkey, Croatia, Serbia etc. The work of the two editors involves the following: Recruiting authors when a current author can no longer contribute or when a new country is added; Assuring that the manuscript is within the page budget and delivered to the publisher by the production deadline; Assuring that each entry is accurate, in clear and grammatical English (this would be a particular responsibility of this position), and includes all of the required elements; Working with the authors to resolve any ambiguities or inconsistencies in the reports; Writing the editors' introduction to each volume, highlighting common trends and important issues. The position requires significant commitment and applicants should be prepared to be proactive in running the publication day-to-day and also developing it (alongside the publisher and the Publications Board) in the longer term. It is expected that applicants will come from an ECPR member, or associate member, institution. The successful applicant will receive an annual editorial fee, an administrative/editorial support fund, and a fund to cover travel expenses incurred in attending meetings related to the journal.
