### **Collective Identity and Practices of Citizenship in Postcommunism**

**Date:** February 22-23, 2013

**Site:** Wrocław, Poland

**Organiser:** University of Wrocław, University of Potsdam

**Topics:** This conference aims at gathering scholars in order to discuss practices of citizenship in post-communist countries. The organizers of the conference are specifically calling for works that address practices of citizenship with a comparative approach that takes into consideration changes occurred since the beginning of the 1990s with the dissolution of socialist federations. Other changing factors to be included in the research works are population dynamics as migration and resettlement after warfare, amendments to citizenship regimes, including issuing passports to ethnically kin folks and granting extraterritorial citizenship. Papers reflecting on the role of formal and informal education, cooperation between individuals through social, political and cultural networks are particularly

welcome. Social, political and cultural practices as practices of active citizenship will also be analyzed. Papers can deal with policies of education and policy initiatives, with a special emphasis on civil society involvement. Not only local and domestic, but also regional and European dynamics will be discussed by international scholars at the conference. Selection of key issues to be discussed: Conceptual and theoretical changes of focus in understanding the post-communist citizenship; Institutional/legal developments of citizenship in the post-communist countries with a focus on controversies; The role of transformation processes for the citizenship practices in those countries; Practices of citizenship and social coherence in the countries in question; Citizenship and civic education (the role of the education system vis-à-vis citizenship); Post-communist citizenship and nationalism (Is there a 'crisis of the hyphen' in post-communist countries?); Power and citizenship in the post-communist countries (the role of inequality and class stratification); The impact of external actors such as the Russian Federation, the U.S. or the EU on the citizenship practices in post-communist countries.

How do we elicit and / or read CVs, photos, Facebook profiles, test results, biographies, obituaries, interviews, and other would-be ways of understanding people?; Different perspectives: How do different theoretical or disciplinary perspectives shape our understanding of people? What are the benefits and the threats of drawing on, and combining, different disciplinary perspectives in our research papers/studies? Articles that engage in a comparative approach, connecting different concepts, materials, methods, situations, pieces of research or other social realities, are particularly welcome.
